It does so through engagement with the appropriate public authorities *(how)* for the purpose of enhancing the well-being of the residential community in the inner-city *(why)*

This strategic plan seeks to **pursue** aspects of sustainable development and local democracy considered important by the inner-city residential community; **respond** where possible to reputable, relevant and independent research concerning sustainable development and local democracy; and **support** at a local level the relevant United Nations Development Programme's Sustainable Development Goals (2015–2030) unanimously adopted by all members of the United Nations on 25 September 2015

Strategic Priorities

As an interface between the inner-city residential community and public authorities the organisation seeks to:

- Be progressive and proactive it promotes sustainable development perspectives that advance the social, economic, environmental and cultural aspects of the inner-city and of the wider city as appropriate
- 2. Be influential and responsive it fosters **local democracy** by representing and acting as an advocate for the interests of the inner-city residential community
- 3. Build a community-driven organisation with the **capacity** to realise its mission





Sustainable Development

Promote sustainable development perspectives that advance the social, economic, environmental and cultural and aspects of the inner-city and of the wider city as appropriate

1. SOCIAL

1.1 Good Health and Well-being (UNDP Goal 3) – ensure healthy lives and promote well-being for all at all ages

Contribute to public authority initiatives, community reference groups and forums around the sale and supply of alcohol

2. ENVIRONMENTAL

- 2.1 Affordable and Clean Energy (UNDP Goal 7) ensure access to affordable, reliable, sustainable and modern energy for all Foster public authority support for more sustainable energy options to reduce greenhouse gas emissions

Local Democracy

Foster local democracy by representing and acting as an advocate for the interests of the inner-city residential community

1. TRANSPARENCY AND ACCOUNTABILITY

- 1.1 Monitor relevant public authority legislation and policy developments that impact the inner-city residential community
- 1.2 Inform the inner-city residential community of relevant public authority legislation and policy developments and seek their feedback as appropriate

2. ADVOCACY AND CRITIQUE

2.1 Lead advocacy (including presenting submissions) that represents the interests of the inner-city residential community around relevant public authority legislation and policy developments

3. COLLABORATION AND POLICY

- 3.1 Collaborate with public authorities and their relevant personnel through regularly organised meetings
- 3.2 Organise pre-election candidate meetings with the relevant public authority personnel to develop an understanding of their policy positions around sustainable development and local democracy

Building Capacity

Build a community-driven organisation with the capacity to realise its mission

1. CONNECTIVITY AND COLLABORATION

- 1.1 Enhance connectivity with internal stakeholders through activities that build their support, participation and involvement around ICW
- 1.2 Strengthen collaboration with external stakeholders with whom ICW has partnerships and cooperative relationships

2. MARKETING AND COMMUNICATIONS

- 2.1 Market and promote ICW to its internal and external stakeholders
- 2.2 Communicate the ICW message to its internal and external stakeholders through mainstream and social media

3. ORGANISATIONAL SUSTAINABILITY

- 3.1 Grow funding streams, membership, expertise, the application of technology and the use of community-focused resources to support ICW sustainability
- 3.2 Digitally preserve ICW history including that of its personnel, milestones, achievements and awards
- 3.3 Apply the eight core operating principles embodied in the ICW constitution, including to uphold the principles of partnership, participation and protection concerning the **Treaty of Waitangi** and to use the **transformative action** model of engagement

Sustainable Development

Sustainable development has been defined as development that meets the needs of the present without compromising the ability of future generations to meet their own needs. Sustainable development calls for concerted efforts towards building an inclusive, sustainable and resilient future for people and planet

For sustainable development to be achieved, it is crucial to harmonise three core elements: **social** inclusion, **economic** growth and **environmental** protection. These elements are interconnected and all are crucial for the well-being of individuals and societies

To this end, there must be promotion of sustainable, inclusive and equitable economic growth, creating greater opportunities for all, reducing inequalities, raising basic standards of living, fostering equitable social development and inclusion, and promoting integrated and sustainable management of natural resources and ecosystems
