Intensification - for some.....

....is continuance for Inner City Wellington.





#### **A TIME OF CRUCIAL TRANSITIONS**

*Issues that currently exist ONLY being exacerbated by the increase in speed of the intensification.* 

Not enough public amenities **now**, public spaces, green spaces etc.

The deficit will grow as the intensification accelerates.

#### Infrastructure Deficit:

The infrastructure relating to 3 waters and public transport (for residents).

This will only worsen as the intensification accelerates.





IT IS FACT that the City has not been able to keep up with these issues at the current rate of residential development.

HOW can we have any confidence that this new long term plan can keep up with accelerated development let alone catchup the existing deficits in public amenity and infrastructure.

HOW it has worked in the past has failed to deliver what is required - what is different this time? Wastewater spilling into harbour for at least a decade

> Wellington sewage spills 20 times higher than acceptable target

Raw sewage spills onto Lambton Quay, covering footpath

\$12 billion isn't nearly enough: The scale of Wellington's infrastructure deficit

Poo trucks all night, then repairs all day, after sewage pipe bursts

Audit New Zealand warns Wellington City Council is risking more burst pipes
